

ISAAC AUSTIN, farmer, residence section 17, Town of Lake, post-office, Milwaukee, was born in Argyle, Washington County, N. Y., October 2, 1828. He left his native place in 1841, and went to New York City, where he spent one year, and then came to Wisconsin in July, 1842, and located in the Town of Lake, on his present farm. He was married in Milwaukee County, December 6, 1846, to Sarah S. Fitch, daughter of John B. and Gertrude (Carroll) Fitch. Mrs. Austin was born in Upper Canada, her family being New York people. They have a family of ten children, all living. John H. resides in Nebraska. Milo, married to Ella Record, also living in Nebraska. Edward, married to Elizabeth Douglas, living in the Town of Lake. Ella, now Mrs. Edward Baldwin, residing in Dakota. Sarah, now Mrs. Zacharia Douglas, living in the Town of Lake. Mary L., Esther G., William J. and George I., all living at home.

DANIEL T. PILGRIM, farmer, section 31, post-office, West Granville, was born in Lincolnshire, England, November 8, 1832; came to America in 1844, with his parents, Joseph and Elizabeth (Wells) Pilgrim. He settled in Waukesha County, in 1844. His father died in 1865, aged 78 years, and his mother died April 21, 1880, aged 88 years. In 1856 he married Miss Sarah Jeffreys, who was born May 21, 1826. Her parents, William and Mary (Winsett) Jeffreys both died here. Her father in 2877 and mother in 1875. They have six children, Florence E., born June 7, 1857; Joseph H., born April 11, 1858; Daniel T., born December 10, 1859; Caroline E., born July 19, 1861; Lucretia J., born April 23, 1864; William F., born April 24, 1866. Mr. Pilgrim was deprived of many of the advantages which his brother enjoyed in his youth for which he has made ample amends. He has a farm as well cultivated as any in the county; having eschewed politics and trade from a desire to live a peaceful and happy life as well as to develop the agricultural interests of his county, in which enterprise he has succeeded to an extent probably not excelled by any farmer in the county. He has for ten years been a member of the State Agricultural Society, and is its present Vice President, to which office he has been twice elected. He is also a member of the Northern Wisconsin Agricultural Society. At the State Fair of 1875 he received the first prize for the best bushel of barley, also took twenty-three premiums, netting \$134, for the best display of field products. He received \$20 and the grand silver medal. In 1876, he took thirty premiums amounting to \$200. He has several times taken the \$25 special premium offered by the Chamber of Commerce for the best Spring and Winter wheat. He has a fine collection of silver prizes taken on these occasions of which he is justly proud. Mr. Pilgrim is a member of the Beaver Creek Grange No. 235.

S. C. ENOS, farmer, section 23, 70 A., post-office, Good Hope, was born April 1, 1817, at Rutland, Jefferson County, New York; a son of Orin and Zeruah (Calkings) Enos. He came to Milwaukee in 1837 and obtained a position on the *Milwaukee Advertiser*. He learned the art of printing in the office of the *Democratic Standard*, at Watertown, New York, and was also the manager and owner of a job printing office at Sackett's Harbor, New York. His health failing him, he had previously, by the advice of his physician, followed the lakes and was one of the crew of the "Solomon Juneau" on her first trip to Cleveland. In the Spring of 1840 he purchased an interest in the *Milwaukee Advertiser*, but in 1842 was obliged to sell out, his health again failing him, and returned to his farm where he has since remained. He was married, March 25, 1838, to Miss Sylvia, daughter of James Edwards, of Jefferson County, Wisconsin. Mr. Enos was a member of the first Board of Supervisors of the town. He was Justice of the Peace from 1844, to 1864, when he enlisted for three years in Company A, Thirty-eighth Wisconsin Volunteer Infantry. He is a member of the Beaver Creek Grange.

E. J. S. DANIELS, telegraph and station agent, at Granville, on the Chicago & Northwestern Railroad, was born at Craftsburg, Vermont, December 9, 1845, is a son of Isaac and Mary (Scott) Daniels. He came West with his parents in 1846. September 4, 1861, he enlisted at Big Bend, Illinois, in Company A, Thirty-third Illinois Volunteer Infantry, and served until December 20, 1865. He participated in several engagements, important among which were Champion Hill, Jackson, Mobile, siege of Vicksburg and others. In 1870, he took charge of the telegraph station at Camden Mills, Illinois, and subsequently had charge of the stations at Erie and Alpha, Illinois, coming to his present position in 1873. Mr. Daniels was married December 17, 1876 to Miss Mary J., daughter of Freeman and Elizabeth (Davis) Layton. She was born December 18, 1857. They have one child, Carrie, born November 20, 1877.

MISS MAGGIE HARRINGTON, teacher in school district No. 7, P. O. Granville, was born March 25, 1850; daughter of Timothy and Margaret (Lynch) Harrington, who came to America in 1840. Her mother died in 1875, aged fifty-two years. Mr. Harrington now manages his farm of 120 acres in section 21. Miss Harrington has been successfully engaged in teaching for the past fourteen years.
