children living are; Orlo, Elvira L., Lucinda C., Charlotte E., Mary F., Ann E., Charles W., Lewis S., Ellen E., Elnora M., George W., and Jason C. Of these Orlo, Mary, Laura and Ann are married, and Orlo, Elvira, Lucinda, Charlotte and Elnora were for some years teaching in the public schools. Mr. Everts was engaged in farming until 1857, when he purchased a stock of goods and followed general merchandising and farming until 1867, when he sold his store, and has since made farming his business. He was for twelve years Justice of the Peace, and being reelected, refused to serve.

GEORGE W. EVERTS, farmer, section 17. 320 acres, was born August 8, 1843, on the farm he now owns, where his parents, Charles P. and Caroline (Chandler) Everts, settled in 1835. His father died in 1871, and his mother in 1876, aged 72 and 71 years respectively. June 13, 1872, he married Miss Mary, daughter of Edward and Julia (Brown) Miller, who was born May 3, 1845. They have four children: Edward, born April 1, 1874; Charles P., born September 21, 1876; Isabel, born June 25, 1878, and Paul E., March 10, 1879. The mother of Mrs. Everts died in 1850, and her father still lives at St. Paul, Minn., where he is running a type foundry. He opened the first type foundry in Milwaukee, in 1856. Mr. Everts has held several town offices, and is President of the Granville and Germantown Fire Insurance. His farm is well cultivated and stocked, and he is a progressive and practical farmer.

JOHN SCHMIDT, farmer, section 10, was born December 18, 1831, at Bauner, Germany, a son of Michael and Margaretta (Pugter) Schmidt. He settled on his farm in 1850. In 1855 be married Miss Wilhelmina Lujow. They have seven children, as follows: Louis; Annie, married; Paulina, married; and Samuel, John, Emma, Willie, at home.

WM. J. SCHLAPMAN, farmer, post-office Good Hope, section 23; was born, July 4, 1850, in Mecklenburg Germany, a son of Frederick and Mary (Weigert) Schlapman. He came to America in 1865, and was married October 16, 1868, to Miss Lena, daughter of Frederick and Adalida (Doebert) Tischafer. Mr. Schlapman owns and operates a creamery producing 100 pounds per week, and intends to enlarge his establishment the coming season.

JACOB STEINMETZ, post-office Granville; born in Kengerhein, Germany, June 25, 1840, a son of Jacob and Elizabeth (Nant) Steinmetz. He came bere with his parents in 1843. Mr. Steinmetz was married in 1865 to Miss Ellis, daughter of Jacob Stockly. They had four children, only one of which, Jacob, born in 1875, is now living. He enlisted in 1862 in the Twenty-ninth Wisconsky Infantry Volunteers, and served until the close of the war. He is the proprietor of the Granville House, which he is at present running.

ANDREW KLUMB, post-office Granville; was born in the Town of Mequon, Ozaukee County, son of Christopher Klumb, who died in 1854. Mr. Klumb settled here in 1874, and engaged in merchandising, carrying a general stock of dry goods and groceries. In 1878, having enlarged his buildings, he opened a hotel, and is still managing both branches of his business. In 1873 he married Miss Agnes Pheil, and has two children—Rosa Camilla aged 7 years, and Mary Lenora aged 4 years.

PETER PORTH, section 33, post-office West Granville; was born in Prussia November 22, 1823, a son of Henry Porth, who is now living in the Ninth Ward of Milwaukee, aged 83 years. Mr. Porth's mother nec Barbara Welch, died November 15, 1869, aged 69 years. He came to America in 1847; settled at this place in 1865, and is at present proprietor of the Seven Mile House. In 1857 he married Elizabeth, daughter of John and Mary (Fitzdom) Hammerschmiedt. They have had nine children—Mary aged 22 years, Elizabeth aged 20, Ottilla aged 18, Caroline 14, Anton 12. Ludwig 9, Katie and Peter 4, and Francisco 1 year of age. Mr. Porth has served on the Town Board one year. He was Assessor two years, Justice of the Peace from 1870 to the present time. In 1874 he was elected to the Legislature. Mr. Porth has three brothers, John, Anton, and William, all living in Milwaukee.

CARL HENRY ULMAN, farmer, section 6, 91 acres; born November 21, 1830, at Ludendorf, Prussia, son of Servatius and Charlotte (Trimborn) Ulman. His father died December 8, 1880, aged 84 years, and his mother is still living, aged 83 years. He came to this place in 1845. Mr. Ulman was married May 28, 1854, to Miss Caroline, daughter of Michael and Agnes (Neuyer) Hoffmann, of Waukesha County. She died December 12, 1878. Mr. Ulman was Assessor, Supervisor, and Chairman several years, and acts as agent for agricultural implements. He had twelve children as follows: Servetius, the oldest son, was drowned in the Milwaukee River, June 22, 1880, aged 24 years; Charlotte, aged 23; Henry Joseph, aged 22; Agnes, aged 20 years, Maggie, died September 25, 1870, aged 9 years; Freddie J., born March 25, 1865, died in September, 1880; Anna, born in September, 1866, died while yet an infant; Mary C., born October 7, 1867, died March 5, 1873; Elizabeth, born November 4, 1869; Phillip, born March 2, 1872; Emma, born April 2, 1875; Josephine C., born June 29, 1877.
